#### **GENERAL RULES & NOTES**

- The 2-meter rule is not in effect.
- OUT OF BOUNDS: OB areas (including water and traditional golf greens) are primarily defined by a white painted line or white string/rope. Where present, white stakes serve as a visual aid for OB lines. Where fencing is used, the inside edge of the fence posts is the OB line. As is standard, the line itself is considered OB. (806.02)
- OB WATER: For any OB water that is not marked with a painted line or rope, a disc coming to rest surrounded by water is considered OB.
- HAZARDS: Hazard areas are defined by a yellow painted line. The painted line is considered to be part of the hazard. By rule, discs coming to rest in a hazard area incur a penalty throw, but the lie is not relocated. (806.05)
- Ad walls that are parallel to an OB line DO NOT serve as the OB line. The OB line will be defined by a painted line running in front of and parallel to the walls. The minimum distance between the walls and OB line is 1 meter.
- DROP ZONES: Optional Drop Zones (DZ)
  may be provided on holes for tee shots
  that come to rest OB. Unless otherwise
  specified, players may re-throw from
  their previous lie (tee), from where the
  disc was last inbounds, OR from the Drop
  Zone. One penalty throw is assessed no
  matter which option is chosen.
- OB RULE RESTRICTIONS: Where noted, Drop Zone use may be required after an OB throw, or a player's standard options

- after going OB may be restricted. PDGA rules waivers have been obtained for these holes, and are marked accordingly.
- MANDATORIES: Mandatory Routes are played according to PDGA Rule 804.01. An arrow will be affixed to an object defining the left or right boundary of the restricted plane by pointing to the side of the object opposite the restricted plane. The restricted plane continues away from the marked object, as indicated by an orange painted line, and continues in the same direction of the line to infinity. The restricted plane extends vertically from the painted line to infinity bounded by vertical planes on each edge of the line. If part of a thrown disc clearly enters into a restricted plane in play for the hole, the player receives one penalty throw. The lie for the next throw is the **DROP ZONE for that MANDATORY, unless** otherwise noted. In the case that a Drop Zone is located more than 10 m from the mandatory object, a PDGA rules waiver has been obtained.
- RELIEF: Players may obtain relief backward on the line of play, without penalty, from temporarily placed advertising assets, permanent sign posts, or fairway markers, per PDGA Rule 803.02 (A). As the rule states, "unless greater relief is announced by the Director" instead of only taking the closest lie that provides relief, the Tournament Director has granted up to Im relief from the aforementioned assets/obstacles.
- CASUAL OBSTACLES: Per rule 803.01 (B) (1), "A casual obstacle is ... any item as designated by the Director," spectator stakes and ropes that are in-bounds

have been designated as casual obstacles, and may be moved and replaced if they impede a player's stance.

- CASUAL AREAS: Players may obtain relief from unmarked casual water per PDGA Rule 806.03. Areas marked with orange paint are designated as casual areas.
- Per PDGA waiver, players are responsible for friends or family who are spectators and who attempt to join the playing group in violation of CM 3.05.G. Players will receive courtesy violation penalties under 812.C if this occurs.

#### **HOLE-SPECIFIC NOTES**

#### HOLE 1

**OB:** Woods on left where marked; Lake; Fence and beyond on right side of fairway (inside edge of the fence posts define the OB line); Golf greens and tee boxes.

#### HOLE 2

**OB:** On/over cart paths; Golf greens and tee boxes.

#### HOLE 3

**OB:** On/over the cart path right; Golf green. **HAZARD:** Sand traps.

#### HOLE 4

**OB:** Golf green; Water/Pond; On/over cart path; \*\*Private property on left side of fairway OB where marked by stakes.\*\*

**HAZARD:** Sand trap.

**WARNING:** Traditional golf green is OB. DO NOT walk on traditional golf green.

#### HOLE 5

**OB:** Water; Golf greens and tee boxes.

**HAZARD:** Sand traps.

#### HOLE 6

OB: Cart path on right is OB line until where marked at end of tree line, then turns right, and connects to the 2nd cart path which becomes OB line from there; Pond; Golf Greens and Tee Boxes; Left side of fairway and where marked.

**HAZARD:** Sand trap.

#### HOLE 7

**OB:** On or over golf fairways on left and right are OB as marked; Golf green; Off course property left.

**HAZARD:** Sand trap.

#### HOLE 8

**OB:** Traditional golf green.

**HAZARD:** Sand traps.

#### HOLE 9

**OB:** Pond; Golf tee box; On/over cart paths where marked;. Over the far right side of the golf fairway where marked.

#### HOLE 10

**OB:** Private backyards behind basket (white columns mark OB line); Barn Roof; On/over cart path.

**NOTE:** Players may take up to 1 meter relief from barn.

#### HOLE 11

**OB:** Water; Golf green; Residential area long of hole.

**HAZARD:** Sand trap.

**NOTE:** DO NOT go onto private property.

#### HOLE 12

**OB:** Water; Practice greens; Parking lot; Golf tee box; Roof of cart barn; White rock area; In or on pavillion marked by paint.

**NOTE:** Players may take up to 1 meter relief from the barn. Cart paths are in-bounds on this hole.

#### HOLE 13 PDGA APPROVED DGPT

**OB:** ISLAND GREEN. Tall grass; Cart path leading to green where marked.

**DROP ZONE:** After any tee shot coming to rest OB, player must proceed to DZ +1 penalty throw. Standard OB rules apply on all subsequent throws.

#### HOLE 14

**OB:** In/over tall grass on both sides of the fairway; Fence and beyond.

#### HOLE 15

**OB:** Left side as marked all the way to the basket; Behind the basket as marked; Fence line and private property on right side of fairway.

#### HOLE 16

**OB:** Practice greens; Tall grass on left where marked.

#### **HOLE 17**

**OB:** Tall grass on left side.

**MANDATORY:** Discs must not enter restricted plane right of marked tree. If MANDO is missed, proceed to DZ +1 penalty throw.

#### HOLE 18

**OB:** Patio area; Practice greens.
